

TOWN COUNCIL PROCEEDINGS

JANUARY 17, 2023

JACKSON, WYOMING

The Jackson Town Council met in regular workshop in the Town Hall Council Chambers located at 150 East Pearl in Jackson, at 1:30 P.M. This meeting was held in-person and through the Zoom platform. Upon roll call the following were found to be present:

Department Director Updates. Susan Scarlata and Tyler Sinclair gave updates on behalf of the Community Development Department. Steve Ashworth gave an update on behalf Parks and Recreation Department. No motions were made.

Parklet and Town Square Ambassador Recap. Carl Pelletier, Johnny Ziem, and Lea Colasuonno made staff comment. Justin Walters and Rick Howe with the Chamber of Commerce made partner comment. Brian Schilling made public comment. Council held discussion with staff. - a) Proceed with final design of the Simon Lane realignment
- b) Pursue combining the Simon Lane realignment with the S4 Flats development construction in summer 2023
